Important Notice for Parents with Children in ANY Playschool

Recently, the Callingwood-Lymburn Community League (CLCL) has undergone some very significant internal and external reviews which have necessitated large scale changes to our own operations including our gaming accounts (AGLC), insurance, WCB (Workers' Compensation Board) and overall policies and procedures. The CLCL has made considerable efforts to bring the league into full compliance with all our requirements.

The most recent change that affects our operation relates to our insurance program with the Callingwood-Lymburn Community Playschool (CLCP). We have received clarification from our insurance broker, Foster Park Brokers, regarding our liability coverage with respect to the playschool program. It is necessary that all children registered in the program have a CLCL membership. This also extends to family members who participate in the program as volunteers. As children cannot purchase a membership, it will be necessary for all families to register for a family membership. Unfortunately, membership in other community leagues will not provide the necessary insurance coverage.

On that note, it is advised that if you have a child enrolled with another community playschool and have purchased a CLCL membership as a condition of enrollment, you verify with that playschool the presence of adequate insurance coverage. Our insurance will not cover you in this instance. Each community league takes care of its own liability insurance based on the programming offered. Foster Park Brokers works with each league on an individual basis, tailoring the insurance coverage to suit their needs. There is no general blanket insurance that each league purchases. The league that is running your child's playschool program may have taken out additional insurance coverage for this situation.

We thank you for your consideration in this matter and hope everyone understands the great efforts the CLCL is making to provide the highest level of service to our community and support all of our programs.

Traffic Shortcutting Pilot: Ormsby Road

The situation along Ormsby Road has raised legitimate concerns regarding the peak traffic volumes and excessive speeds of commuters seeking a shortcut to the Henday. In this residential neighbourhood, there are at least 40 driveways that exit right onto Ormsby Road – which was never intended nor designed to serve as the major through-road it has become.

The City's traffic Shortcutting Pilot was established to find efficient, easy-to-implement interim solutions for neighbourhoods who have faced long-standing or escalating traffic management problems. In the past, neighbourhoods were encouraged to work collaboratively with the City to develop mutually-agreed traffic management plans. However, the number of neighbourhoods waiting for this process far outstrips the resources available. Not every residential road requires complex infrastructure or design changes to successfully change driver behavior – sometimes, a small change can be effective in encouraging drivers to seek alternate, non-residential routes to their destinations.

This project is seeking to determine if that is the case by using different traffic measures in each of the four neighbourhoods, which are tailored to their unique concerns and designs. Crucially, as a pilot project, the goal is to generate data to compare the traffic volumes and speeds before and after the measures are implemented to determine their success. Feedback from residents and commuters will be essential in this.

Unfortunately the current problem with strategies to reduce shortcutting is that traffic is like water – it always finds a route somewhere. This means that while many drivers will simply adjust their speeds and their travel times, those drivers dissuaded from cutting through Ormsby Road will often turn to adjacent neighbourhoods for the illusion of that slightly quicker, slightly easier route.

For those of you in the adjacent neighbourhoods – yes, you may see an increase in through-traffic. That does not mean that the measures are useless. It means that the sheer volume of traffic has to be spread evenly through the area for efficient travel. It means that we may need to consider changing our attitudes – and enforcement policies – on residential roads. It means that the City needs to invest in improving and maintaining efficient arterial routes that can keep pace with increasing traffic volumes from a growing population. And it also means that "not in my backyard" or "not on my street" cannot be sustained – we might all have to accept small inconveniences so that traffic can be improved, and appreciate that consideration for our neighbours can make the roads safer for everyone.

The City is looking at ways to resolve neighbourhood traffic issues from a holistic, city-wide perspective, as well as to respond to the concerns of residents whose daily lives are impacted.

Edmonton, November 3, 2015: The outlook for Edmonton's housing market remains stable. The average residential price in October for the Edmonton Census Metropolitan Area (CMA) is up 1.72% year-over-year (YoY) despite reported sales being down 15%. Single family sales are down 14%, with prices up 3% YoY. Condo sales are down 17% YoY and prices are down almost 6% from October of 2014.
